### WIRING CONFIGURATIONS:

**RED** - Apply +VDC to wire to activate warning function

**BLACK** - Ground Wire. Apply the wire to the power to activate the product.

**YELLOW** - Synchronization, flash pattern selection and reset

- Connect YELLOW wires of all heads together for synchronization
- To change flash patterns, apply +VDC for less than 1 second and release
- Flash patterns will be reset when YELLOW wires are connected to RED wire for more than 5 seconds

**WHITE** - Alternation. With the power off, connect the wire from one lighthouse to + VDC and leave the other unconnected. Their patterns will alternate when the lighthouses are activated.

**GRAY** - Turn signal/Brake light


**PURPLE** - Tail light/Parking light

**PINK** - Reversing light


